A stakeholder coalition to drive global policy commitment and action on stroke





The scale of the global stroke challenge

The global burden of stroke has doubled in the past 30 years. Stroke is a leading cause of death and disability, and projections indicate that by 2050 the burden of stroke will increase by one third. That would represent 355 new strokes every minute, a rise in the annual number of deaths to 9.7 million, and a growing population affected by stroke related disability.

Up to 90% of strokes could be prevented through healthy lifestyle and improving the control of vascular risk factors. As well as the profound human toll, this escalating burden is expected to cost the global economy more than US\$2.3 billion.

An unprecedented opportunity

In September 2025, Heads of State, Ministers of Health and Finance, alongside global health civil society and industry stakeholders, will gather in New York for the fourth UN High Level Meeting on NCDs. With five years left to deliver on commitments set out in Sustainable Development Goal 3.4, universal health coverage will not be achieved without investing in stroke prevention, treatment and care. As the deadline moves closer, September's event represents a crucial tipping point for the global health community and we need a proactive approach to ensure visibility for and action on stroke.

Recent years have seen major advances in stroke treatment and care, but investment in NCDs has fallen chronically short, and access to these life-changing interventions is limited – particularly in low and middle-income countries. We have an opportunity to change this and position an investment in stroke as a key intervention that can help governments accelerate progress ahead of – and beyond – the 2030 deadline.

There is a strong investment case for stroke - the health and economic benefits of investment in prevention, treatment and recovery are clear. Our coalition will support strategic articulation of the opportunity represented by stroke to governments around the world.

Why a Coalition?

The global burden of stroke has doubled in the past 30 years. Stroke is a leading cause of complex and multifaceted, and cannot be solved by one organization or sector alone. Instead, they require a coordinated, collaborative approach that harnesses the skills, experience, and resources of stakeholders across multiple sectors.

Recognizing the value of this unified and collaborative approach, coalitions are a powerful tool used by many leading global health organizations. Bringing together a diversity of perspectives and experiences, they enable coordinated action and advocacy – driving attention and accelerating action towards the pursuit of a common, shared goal.

Why WSO?

As the only global organization with a sole focus on stroke, our diverse global membership base and with our official relationships to international policy-making organizations, WSO is in a unique position to lead a global collective advocacy initiative.

Key activities and outputs

- a collective vision, values, objectives and indicators for the advocacy campaign;
- stakeholder/audience mapping and engagement framework;
- a campaign brand, toolkit and microsite;
- a coherent and flexible key messaging structure;
- policy briefing papers, joint statements and social media activation tools;
- public and member-only events.

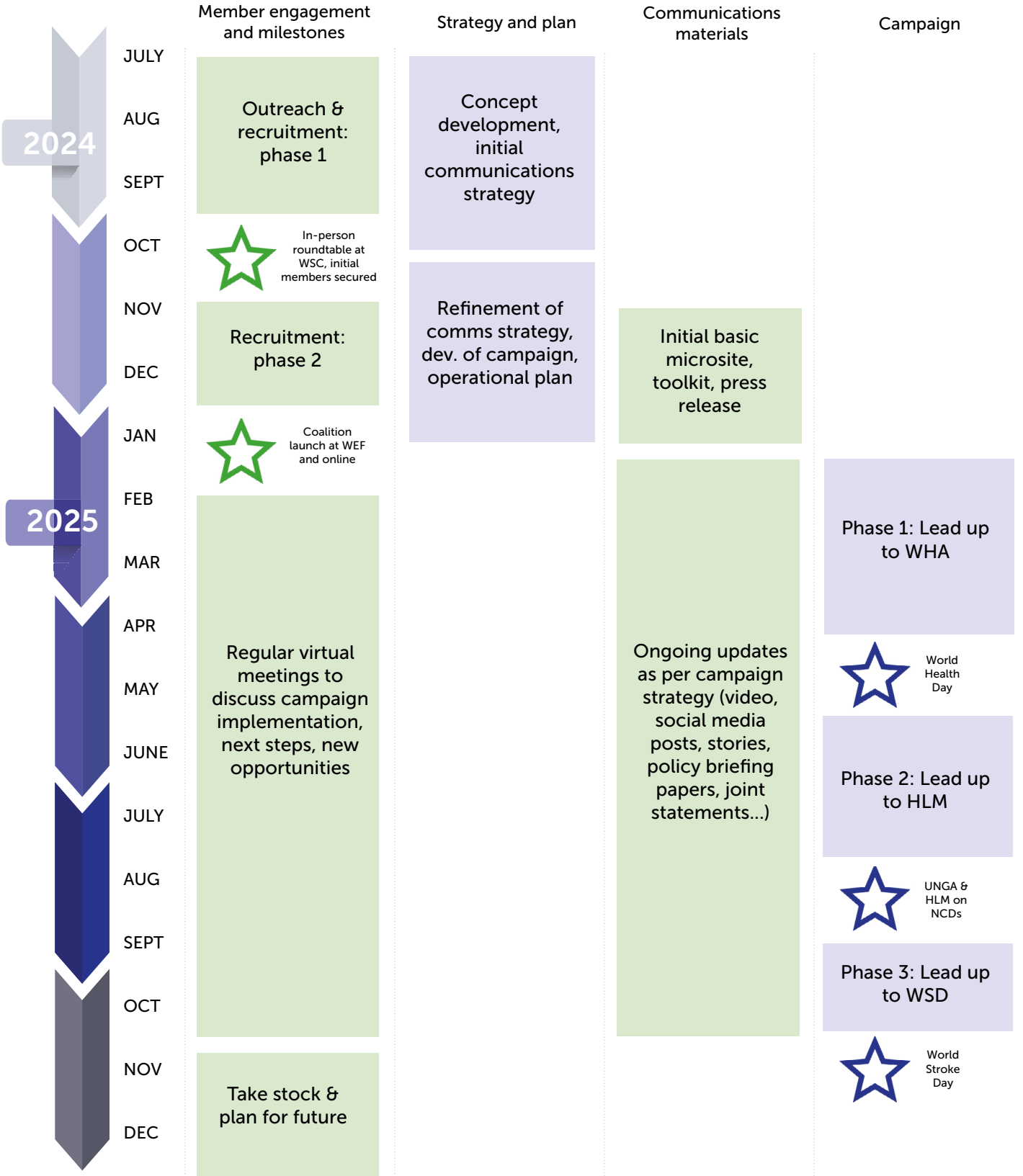
